



## 2025 International Female Ride Day® Photo Share Giveaway Sweepstakes Terms and Conditions

**Eligibility:** To enter, simply submit your International Female Ride Day® (IFRD) 2025 photo using the official IFRD online entry form — and you could be selected to win! Entrants must be 18 years of age or older at the time of entry. No purchase necessary. Limit of one entry (one image) per person.

**Prizes:** Winner(s) of the IFRD Photo Share Giveaway Sweepstakes (the “Winner”) will receive one of the prizes outlined for each winning category. Winners will be selected by random draw under witness supervision. The name provided with the photo submission will be the name entered into the draw.

Submitted images must be taken on IFRD 2025.

### Prize Categories:

- IFRD SELFIE: One to Three (1-3) women in photo.
- IFRD PHOTO: Four to Seven (4-7) women in photo
- IFRD GROUP: Eight (8+) women or more in photo.

### Sweepstakes Details:

- Image entries may originate in any format or colour and be a minimum of 1MB to a maximum size of 3MB.
- Your photo must not have appeared earlier and is a current image taken on International Female Ride Day®. Any suspicions otherwise and or of tampering of the photo are disqualified unless proven otherwise.
- Any person or group who has already won an IFRD photo category in the past five (5) years is not eligible to win.
- Images must be property of the person uploading and not copied from another source.
- Only one prize is awarded per category: IFRD SELFIE; IFRD PHOTO; IFRD GROUP.
- Any images uploaded to the IFRD page Sweepstakes deemed improper or irrelevant to the purpose and topic of the Sweepstakes, are deleted without consult including images which may appear to promote persons, products and/or commercial goods.
- All photos will be displayed eventually in IFRD galleries.

The Sweepstakes commences on 00:01 Friday 2 May 2025, EDT (Eastern Daylight Savings Time) through to Sunday 18 May 23:59 (midnight) EDT/Eastern Daylight Savings Time (the “Deadline”) for submissions.
